- Surplus of \$5900 at the end of 2015 and deficit of \$4400 for 2016. (Partly due to Tree Maintenance and Irrigation)
- Must stick to the 2017 budget with any expenses this year so another deficit doesn't occur.

## Property - Elaine

- JEA Irrigation issue with too much usage. (Nov-Dec 2016)
- Elaine, Matthew, and the landscaper met with JEA to review past usage. Elaine to monitor the daily usage each month.
- Terry moved to turn the meter off on Vestavia Drive, Bill second.
   Passed 3-0 Elaine to handle, just as easy to turn off meter as it is to turn back on.
- Street lights are city owned so please contact JEA with the street pole number and closest address when reporting outage.
- Flowers to be bought by Elaine and planted for the entrance.
- Ponds are in good shape and are at a high level which is always a positive.
- The existing Satellite dishes on homes in the neighborhood will remain in their current position. A new satellite dishes must be approved by the HOA's ARC committee.
