CALL TO ORDER

FINANCIAL STATEMENT REVIEW

Year to date income earned was \$30,125.27 and year to date expenses were \$26,854.18. Accounts receivable totaled \$2,000.00 which reflects one account with two violation fines. Following review, a motion was made, seconded and passed unanimously to approve the financial report (Fitzgerald/Blake).

PROPERTY MANAGERS REPORT

Anna reported on maintenance items that have been completed and those that are still in progress. Elaine continues to monitor and plant annual flowers at the entrances as needed. Anna will contact Ty Blake prior to inspecting the community each month for violations and Ty will join Anna on the drive throughs depending on his work schedule. Both front entrance sign refurbishment was completed by Matthew Broadus Advertising. Anna and the Board will work together to obtain additional bids for pressure washing.

COMMITTEE REPORTS

Covenant Enforcement Committee- Anna provided an updated violations report to the Board for review. There is one homeowner that has received two violation fines totaling \$2,000.00. He has not paid the fines and has not corrected either violation. The Board agrees with the plan to send collection notice for the violation fine. If not paid by September 30, intent to Lien will be considered and the Board may engage an attorney.

Social/Welcome – No Report. There are three volunteers interested in joining the committee. Anna reported that both homeowners are in good standing. A motion was made, seconded and approved to appoint John Demopoulos, June Walker-Tillet and Mary Elizabeth Hayes to the Welcome/Social committee.
